# PORT ADELAIDE PLAZA "WIN AN MG FOR CHRISTMAS" PROMOTION

#### **TERMS AND CONDITIONS**

- 1. Information on how to enter and the prize form part of these Terms and Conditions. Participation in this "Win An MG For Christmas" Promotion (**Promotion**) is deemed acceptance of these Terms and Conditions.

## **ELIGIBILITY**

- 3. Entry is only open to **residents of Australia** who are aged **18 years and over**.
- 4. The following are ineligible: (i) employees of the Promoter or any of the tenants or retailers in Port Adelaide Plaza (Participating Centre) or any of the Promoter's agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter's promotions.

## **HOW TO ENTER**

- 6. To be eligible to enter, eligible individuals must, during the Promotion Period; Spend \$20 or more in a single transaction at any participating retailer (each a **Qualifying Transaction**) within Port Adelaide Plaza (**Participating Centre**). Excluded retailers include NAB, Port Plaza Medical Centre and Port Plaza Lotto.
- 7. During the limited period commencing at **7.30am ACDT on Saturday 16 December 2023** and **ending at 5.00pm ACDT on Sunday 17 December 2023**, eligible individuals will receive **two** entries for each Qualifying Transaction made within that period.
- 8. To enter, entrants must then, during the Promotion Period visit portadelaideplaza.com.au and follow the prompts to the promotion entry page, fully and correctly complete their entry in accordance with the instructions provided and submit the fully completed entry form.

Multiple entries are permitted per person, subject to the following: (a) only one (1) entry permitted per Qualifying Transaction (except during the period set out in clause 7 above when two (2) entries are permitted per Qualifying Transaction (b) each entry must be submitted separately and in accordance with entry requirements.

## **DRAW DETAILS**

- 12. The draw will take place at the Participating Centre at Port Adelaide Plaza, Level 2, 200 Commercial Road, Port Adelaide, SA 5015, at **10.00am ACDT** on **Sunday 24 December 2023** in the presence of an independent scrutineer. The Promoter reserves the right to draw additional reserve entries in case of an invalid entry or invalid entrant.
- 13. The provisional winner will be notified by telephone and in writing within two (2) business days of the draw. A provisional winner will only be deemed the winner once verified by the Promoter.
- 14. The winner's name and postcode will be published on the Promoter's website on 24 December 2022 (portadelaideplaza.com.au).
- 15. Entrants can only enter in their own name and use their own email address. The Promoter reserves the right to request a provisional winner provide proof of identity, proof of residency, and/or proof of entry validity. Proof of identification, residency and entry considered suitable for verification is at the discretion of the Promoter. ## **PRIZES**
